*The Colorado Department of Regulatory Agencies has the general responsibility of regulating the practice of licensed psychologists, licensed clinical social workers, **licensed professional counselors**, licensed marriage and family therapists, certified school psychologists, and unlicensed individuals who practice psychotherapy. The agency within the Department that has the responsibility specifically for licensed professional counselors is the Board of Licensed Professional Counselor Examiners, 1560 Broadway, Suite #1350, Denver, Colorado, 80202, (303) 894-7766. As to the regulatory requirements applicable to mental health professionals: **a Licensed Professional Counselor must hold a masters degree in their profession and have a two years of post-masters supervision.***

I am happy to provide you information about my methods of therapy, the techniques I use, the duration of therapy, (if I can determine it at our first meeting), and my fee structure. Please ask me if you have any questions about these or any other matters. While in therapy you will only be treated and contracted with me and no other person, group, partnership, joint venture, or other entity at this location. In addition to the above, you may seek a second opinion from another therapist and, of course, may terminate therapy at any time. My fee is \$175.00 per counseling hour, duration of 50 minutes.

Your verbal communication and clinical records are legally confidential except in: a) criminal and delinquency matters and other areas as provided in Colorado Revised Statutes 12-43-218 and the HIPPA Notice of Privacy Rights that you have received; b) information shared with your insurance company to process your claim; c) where you sign a release to have specific information shared; and d) if you provide information that informs me that you are in danger of harming yourself or others. If a legal exception arises during Counseling, if feasible, you will be informed accordingly. Clinical records are kept for the purposes of continuity of care. These are retained for seven years after the conclusion of our professional relationship.

*This professional relationship is **our only relationship**. Colorado Law (12-43-214 Revised Statutes) requires that I inform you that in our professional relationship, physical sexual intimacy is never appropriate and should be reported to the Grievance Board. In order to keep our relationship professional, please do not give me any gifts, however small.*

Our relationship will be considered in effect while you are actively participating in your process. If you decide to terminate counseling with me, it is in your best interest to discuss this with me. This is an opportunity for you to orchestrate healthier endings that will be productive for you. **If you have not scheduled an appointment with me for a four month duration, I will need to formally terminate our therapeutic relationship.** I will document this with a letter of termination. Any visit after this termination will require a formal beginning with the proper paperwork and fee agreement.

I am required to report any suspected incident of child abuse or neglect and elder abuse or neglect to law enforcement; (2) **I am required** to report any threat of imminent physical harm by a client to law enforcement and to the person(s) threatened; (3) **I am required** to initiate a mental health evaluation of a client who is imminently dangerous to self or to others, or who is gravely disabled, as a result of a mental disorder; (4) **I am required** to report any suspected threat to national security to federal officials; and (5) **I may be required** by Court Order to disclose treatment information.

*In regard to the use of **Social Media**: I am not going to be Friends with you on Facebook. You may follow the Connect Therapies page on Facebook. I may be a connection with you on LinkedIn (Sally Blevins MA LPC). You may follow my professional pages (Connect Therapies) on Twitter and Instagram, etc.*

Under Colorado law, C.R.S. § 14-10-123.8, **parents** have the right to access mental health treatment information concerning their minor children, unless the court has restricted access to such information. If

you request treatment information from me, I may provide you with a treatment summary, in compliance with Colorado law and HIPAA Standards.

If you should request **treatment records** from me, I may provide you with a treatment summary in compliance with Colorado law.

If an emergency arises for which the client or their guardian feels immediate attention is necessary, the client or the guardian understands they are to contact the emergency services in the community for those services. Sally Blevins MA LPC LCPC will follow those emergency services with standard counseling and support to the client and/or the client's family. If you are involved in divorce or custody litigation, **my role as a therapist is not to make**

recommendations to the court concerning custody or parenting issues. By agreeing to receive services from me, you agree not to subpoena me for court testimony or for disclosure of treatment information in such litigation, to testify or produce records in court in any type of litigation. You agree not to request that I write any reports to the court or to your attorney, making recommendations concerning custody. The court can appoint professionals, who have no prior relationship with family members, to conduct an investigation or evaluation and to make recommendations to the court concerning parental responsibilities or parenting time in the best interests of the family's children.

I have been informed both verbally and in writing of the preceding information and understand my rights as a client/patient as well as my rights as a client, along with my therapist's degrees, credentials and licensing.
